Good afternoon all,

Please find attached the email correspondence regarding the booking enquiry, and confirmation of details. I have looked through the information and it confirms that Mark Mahony was out to deceive RA for this booking with fake business names, ABN and address.

- The business name given QT One Pty Ltd and ABN 63 872 768 812 don't match. QT One Pty Ltd ABN is a registered company with the ABN 48 105 670 577, and the ABN given in the correspondence is for a Trustee for IT One Trust. So Mark has given a fake name and ABN.
- The address Mark gave in the documentation was Suite 577, 165 Auburn Street Goulburn, that address minus the Suite 577 is the Australia Post Office.

We currently don't receive this commercial information on the house approval process but I'm happy to discuss if we would like this additional information added to the form so we can carry out our own Due diligence, if we believe that will be required for all future bookings.

Old Parliament House has several event spaces available for public hire managed through a third-party contractor.

The event on Saturday 8 February 2025, was booked using an acronym.

Once Old Parliament House staff identified the intent of the event, they immediately increased security arrangements to ensure the event ended peacefully and without incident.

As a result, Old Parliament House will be reviewing event booking processes with a view to adding an extra layer of oversight.

The event does not align with the role of Old Parliament House. Our role is to strengthen the understanding of Australia's democratic system.

Talking points for ME team

Does MoAD support “sovereign citizens”?	The event does not align with the role of Old Parliament House. Our role is to strengthen understanding of Australia’s democratic system.
How did this happen?	The event was booked in one of Old Parliament House’s event spaces, which are available for public hire via a third-party contractor. The event was booked using an acronym for the group name.
What did they do at the event?	I am not sure what happened at the event.
What are “sovereign citizens”?	Sorry I am not sure what this group does.
Did MoAD know what the event was about?	No, the event was booked using an acronym.
Were police called?	Police were informed as part of our security response arrangements.
Was there any violence?	No, the event ended peacefully and without incident.
How will you stop this happening again?	We will be reviewing event booking processes and increasing our oversight.

You have rented your courtyard today to a group of Sovereign Citizens for an event. This is the same ideology that set fire to the front doors 3 years ago. I suspect they lied about the booking. I suggest you cancel them or up your security. I am stunned the museum would allow them inside.

1. Purpose

To brief the Board on the GJI event held at Old Parliament House on 8 February 2025.

2. Event Details

2.1 GJI Event – Sovereign Citizens event at Old Parliament House

On Saturday 8 February, a Sovereign Citizens event was held in the Senate Courtyard of Old Parliament House. The event was booked through MoAD's catering firm, Restaurant Associates (RA), and was for an afternoon tea for 100 people.

2.2 Booking Details

- The event was booked under QT One PTY LTD, a PO Box was used for the postal address and a false ABN number was included in the booking. A booking inquiry was also made by the same individual under the event name "Contractor Associations" for King's Hall. The event booking was not progressed by RA as King's Hall cannot be booked during opening hours.
- The name of the event for the Saturday booking was listed as GJI Event.
- The event was for an afternoon tea, for 100 people. AV equipment was not included in the hire package and MoAD/RA did not provide AV support.
- There was no information or documentation that raised concerns about the intent of the event.
- The event fee was \$^{s 47(1)(b)}, and the majority of this fee is for RA costs to provide the event, catering and staff. Under the catering contract, MoAD received \$^{s 47(1)(b)} for hire of the space.

2.3 Sequence of events on the day

- On Saturday, as the event organisers started to arrive at OPH, the Museum Experience Officer (MEO) team leader noticed marked vehicles and individuals carrying flags. The MEO team leader asked the organisers as they entered OPH who they were and what GJI stood for. The organisers refused to say who they were.
- The organisers handed out printed material and it was through this material that the MEO staff ascertained that GJI stood for Grand Jury Indictment. Other individuals at the event were associated with "Corruption Whistleblowers QLD", "Phoenix Taskforce" and some attendees wore shirts marked as "Lore Sheriffs".
- The organisers handed out hardcopy material about the event, and the material and online content stated that the event was to be held at Magna Carta Place and a special

announcement would be made. OPH was not mentioned in the material, however it appears the announcement was that the event would be held in OPH.

- The MEO escalated the issue to the Head of Facilities, and additional security guards were engaged, senior staff attended, and the AFP was notified of the matter. The AFP did not attend the site during the course of the event.
- As the event commenced, the organisers started to live-stream the event, advised that they expected 500 people to join the event at OPH.
- Once the numbers of participants exceeded the event limit of 100, MoAD staff refused entry to people. Entry was also refused to individuals who did not meet the Conditions of Entry (carrying flags, not wearing shoes). Owners of two dogs, tied up at the front of OPH, were requested to remove the dogs.
- Participants were mainly respectful, with a small number of participants being aggressive and rude to staff and volunteers.

2.4 Follow Up


MoAD received a series of formal complaints from a member of the public on Saturday afternoon. As the event was streamed, MoAD also received comments online from members of the public criticising MoAD for hosting the event.

MoAD received the first media inquiry from the Canberra Times, on Sunday afternoon, followed by inquires from the Australian, ABC, and Crikey the following day. A statement was prepared in consultation with the Chair. A copy of the media statement was provided to the Minister's Office and Office for the Arts.

2.5 Changes to Procedures

MoAD has introduced the following changes in the booking and approval system to minimise the potential for this situation to arise again. As a number of events are booked by individuals (e.g. weddings, other private occasions) it is difficult to completely eliminate the possibility of this happening again. This is why we are also implementing the ability for MoAD to cancel the event prior to or during the event as referred to below.
